NOTICE INVITING QUOTATION

Quotations in sealed envelope are hereby invited from experienced contractors/agencies for "Supply of Skilled OBM Operator and Contingent Labour on need basis" for survey / logistic support to FRP boats and miscellaneous activities in between Majhua to Kahalgaon (370 km) stretch in NW-1 and other waterways under R.O. Patna, as per the terms and conditions given below, for the period 01 September 2026 to 31 March 2027. The details of the work and B.O.Q. are enclosed as Annexure-A with this N.I.Q.

Sealed quotations will be received up to 3:00 PM on 24.08.2026 at the Regional Office of the Director, I.W.A.I., P.O. – Gulzarbagh, Patna – 800007 and will be opened on the same day at 4:00 PM.

The contractors/agencies or their authorized representatives (with authorization letter) who have submitted the quotations may also be present during opening of same by the committee members of R.O. Patna.

The rate of skilled OBM Operator and Contingent Labour shall be as per C.L.C. minimum wages. The contractors/agencies shall quote Service Charges only, legibly both in figure and words, and shall be valid up to 30 (Thirty) days from the date of opening. The name of the work should be clearly written on the sealed envelope.

I.W.A.I. reserves the right to accept or reject any or all quotation(s) without assigning any reason thereof.

Terms and Conditions:

- 1.0** The quotation shall be submitted in a sealed envelope, clearly superscribed with the NIQ number and subject. The B.O.Q. shall be submitted strictly in the format given at Annexure-A, duly signed and stamped by agency, without any deviation or condition.
- 2.0** The contractor/agency must pay the OBM Operator and Contingent Labour not less than the minimum wages fixed by the Government / Chief Labour Commissioner (C), as revised from time to time.
- 3.0** The quoted rate shall be expressed in Indian Rupees (INR). Only Service Charges shall be quoted by the contractor. The GST amount shall be released on submission of proof of remittance. No other claim on this account shall be entertained.
- 4.0** The quotation shall be evaluated on the basis of the Service Charge (%) quoted. In case two or more eligible bidders quote the same Service Charge, the bidder whose last executed similar work to any Government / Quasi-Government / P.S.U. has the highest work done value shall be considered.
- 5.0** The quotation must be accompanied by copies of PAN Card, GST Registration Certificate, valid Trade Licence, Firm Registration Certificate and a cancelled cheque / bank mandate.

6.0 The bidder shall furnish documentary proof of similar works done at any Government / Quasi-Government / P.S.U.

7.0 If the agency is running its business in the form of a partnership or a company, or is a Joint Venture of two or more firms, it shall produce the Partnership Deed / Certificate of Incorporation, as applicable, along with a valid Power of Attorney duly authorising the signatory to sign the quotation, participate in the process and execute the Agreement on behalf of the firm / company / Joint Venture. Quotations signed by a person not so authorised shall be liable to be rejected.

8.0 The manpower engaged shall work strictly as per the directions of the E.I.C. or his representative, and shall follow all safety instructions and protocols during field / river operations at all times.

9.0 Claims for injury or loss of life due to accident, natural calamity or any other cause whatsoever shall be borne by the agency alone and shall not be entertained by IWAI in any case.

10.0 If the services are not rendered within the schedule / period intimated by the Department, Liquidated Damages (L.D.) @ 0.5% per week shall be levied, subject to a maximum of 10% of the work order value.

11.0 The firm shall be required to submit the original tax invoice at the time of submission of claim. Payment shall be released on submission of bill within 15 days, after deduction of statutory dues, if any, and duly certification by E.I.C. / concerned officials.

12.0 On receipt of the work order, the agency shall submit a Security Deposit of 10% of the service charges in favour of "IWAI FUND", A/c No. 0352105000002, IFSC Code – CNRB00005200 (Canara Bank), and shall attend the office at Patna along with two non-judicial stamp papers of ₹1,000/- (Rupees One Thousand only) each, to execute the formal Agreement and Integrity Agreement, within 15 days from the date of issue of the work order.

13.0 The period of engagement shall be from 01.09.2026 to 31.03.2027; however, actual deployment shall vary as per field / site requirement. IWAI reserves the right to increase or decrease the quantity of man-days depending upon actual field requirement, at the same quoted rate, without any change in the unit rate quoted by the contractor / agency, and within the sanctioned financial provision.

14.0 After satisfactory performance of the agency in the supply of manpower, the work order / engagement may be extended beyond its expiry for a further period of One (01) year, at the existing quoted rate of service charges, subject to approval of the Competent Authority.

15.0 The contractor / agency shall not sub-contract, assign or transfer the work, in whole or in part, to any other person or agency under any circumstances. Any violation of this condition shall render the work order liable to cancellation and the Security Deposit liable to forfeiture, besides such further action as IWAI may deem fit.

16.0 Quotations received after the last date and time of submission shall not be entertained under any circumstances.
