- Inland Waterways Authority of India (IWAI) invites online tenders/bids in a two-cover system (Cover I – Technical bid and Cover II – Financial bid) from experience repairer/contractors/firms for “Supply, Installation, Fitting, Testing and Commissioning of Steel Wire Ropes for Cutter Suction Dredger for the year 2026-27”. 10. A signed declaration stating that no alteration has been made in any form in the downloaded tender document is to be enclosed with the tender by the bidder.

11. Tenderer shall agree to the terms and conditions of the tender and submit the tender online duly signed on each page for agreeing the same.

The complete bid as per the tender documents should be placed online at <https://eprocure.gov.in/eprocure/app> by **15:00 hours on 12.10.2026** and will be opened online on **13.10.2026 at 15:30 hours** at IWAI, Regional office Guwahati. The original RTGS for tender fee and EMD should be submitted before closing date and time of submission of bid at Inland Waterways Authority of India, Pandu Port Complex, Pandu, Guwahati-781012. The cost of tender fee is non-refundable.

13. IWAI reserves the right to accept or reject any or all tenders without assigning any reason and no correspondence shall be entertained in this regard. The department will also have the right to award the work to different bidders at the lowest received rate to ensure that the works are undertaken smoothly.

14. Work Experience: -

- i) The tenderer shall have sufficient experience in the supply, installation, testing and commissioning of steel wire ropes/wire rope assemblies used in Cutter Suction Dredgers (CSD), dredging vessels, inland vessels or similar marine applications. Documentary evidence in support should be submitted in the technical bid.
- ii) The tenderer shall have experience in marine equipment supply, vessel repair/maintenance, dredging equipment or related works background, registered with any Major Port of India, MES, IWT Wing of Indian Army, BSF or any other Central Govt. Dept. or non-registered contractors having experience of working with IWAI with similar work.
- iii) Tenderer shall be income tax payee and PAN issued by Income Tax Department shall be submitted above with the technical bid.

- iv) The tenderer shall be registered with GST department and the proof of the same shall be submitted along with the technical bid.
 - v) The average annual financial turnover in the field of Vessel building/repairing should be at least 100% of the estimated cost during the immediate last 3 consecutive financial years and should not have incurred any loss in more than two years during the last five years ending March of the previous financial year 2024-25.
 - vi) Experience of having successfully completed similar nature of works of during last 7 years ending last day of month previous to the one in which this tender is invited should be either of following
 - a. Three similar works costing not less than 40% of the estimated cost, or
 - b. Two similar works costing not less than 50% of the estimated cost, or
 - c. One similar work costing not less than 80% of the estimated cost.

AND

“Similar works are including repair of propelled/non-propelled Inland/ocean going vessels.”
 - vii) Tenderer shall have to submit scan copies of successful work done certificates.
 - viii) Tenderer shall have to submit proof of experience in ship repairing during last 3 years.
