CIRCULAR

Subject : Functioning of IWAI Head Office and Regional Offices from 13th April 2020 onwards within guidelines issued by Government of India to contain the spread of COVID-19

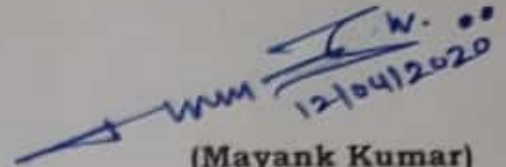
1. This is in continuation to various circulars of IWAI and instructions issued by Government of India and various State Government's for observing lockdown and measures to be adopted for containing the spread of COVID-19 virus.
2. In view of the obtaining situation and further Government instructions on the subject matter, Head Office IWAI will resume functioning from 13th April 2020 onwards in a graded manner with limited staff with in the ambit of Government guidelines on the subject matter.
3. Wing heads may decide on requirement of staff of their respective wings including consultants taking into account local situation of place of residence of staff, their medical condition and other relevant factors. PD & VC (JMVP) may decide regarding deployment of staff at PMU and various Project sites as per requirement and within the Government instructions.
4. All field offices will continue to function with the skeletal staff and will follow instructions issued by respective State Government on the subject matter. Regional Director may decide on the requirement of essential staff for resuming functioning in a graded manner. IWAI Offices at Kolkatta, Guwahati, Patna, Kochi and Sahebganj will ensure regular vessel movements.
5. All other Officers and Staff from HO, IWAI Noida are expected to work from home and will comply with Government Orders on lockdown.
