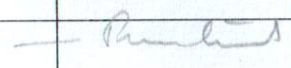

Note : The posts of LDC are filled by 85% by direct recruitment, 10% by LDCE and 5% by promotion. Earlier the reservation roster for direct recruitment was maintained as a running roster taking cadre strength as 24. Now the authorized strength has been reduced to 15 out of which 11 posts are treated as 'deemed abolished' for which case has been taken up for revival. Therefore, the effective authorized strength in the grade of LDC is 4. Out of 4 posts, the present held strength is only 2. Both are likely to be promoted to the grade of UDC and chain vacancies will be available. Therefore, a total 4 vacancies will be available in the year. As per the recruitment rules, all the vacancies will be filled by direct recruitment as there will no vacancy will be allocated to LDCE and promotion quota as any fraction less than shall be ignored for the purpose of counting vacancy. Since authorized strength is less than 13, Reservation Roster Register (13 point roster) will be maintained. As per the revised policy EWS category has also been introduced for direct recruitment. Accordingly, roster has been prepared as per the revised strength.
